Water Operations Manager: Loren Chilson reports the community sign should be coordinated with Public Works before brace is removed. The sign is in the right-of-way and we should obtain permission before digging in the area. There is no 3 Phase power to the well for a few days, he is running the generator 2 hours a day to create more PSI. No leaks, doing well on water usage for the year.
