#### Additional Health Information

#### **Contaminants in Drinking Water:**

#### **Cross Connection:**

You might have seen cross-connection surveys sent to you by mail. Here is a little information on why:

Cross-connections are found in all plumbing systems. It is important that each cross-connection be identified and evaluated as to the type of back-flow protection required to protect the drinking water supply. Some plumbing fixtures have built-in back-flow protection in the form of a physical air gap. However, most cross connections will need to be controlled through the installation of an approved

mechanical back-flow prevention device or assembly.

#### \*\*What Are PFAS?

Per- and Polyfluoroalkyl substances (PFAS) are a large family of chemicals in use since the 1950's, to make a wide variety of stain-resistant, water resistant, and non-stick consumer products. Some examples include food packaging, outdoor clothing, and non-stick pans. PFAS also have many Industrial uses because of their special properties. In Washington State, PFAS were used in certain types of firefighting foams.
